3. The applicants who are applying through the SEZ portal, as they are not yet covered under the SWIT System, are advised to submit their IFSCA application to the respective IFSCA Regulatory Team, along with the SEZ Application, before the deadline dated **7th October 2024**.

4. It is informed that the applicants may ensure that SEZ application filed by them is complete in all respects. It may be noted that **an incomplete application shall not be taken up in the UAC meeting.**
