<u>Update for 53rd UAC:</u>

The applicant sent an email dated May 15, 2025, to the Office of the Administrator (IFSCA) which states the following:

"This is in reference to the queries raised on the SEZ Online Portal bearing **request ID 112500000782, dated 07 February 2025**, regarding the Company IFSCA application filed via the SWIFT portal on 03 February 2025, bearing reference number 20251116, for registration under the IFSCA Ancillary Service Framework. We would like to respectfully submit that the Applicant did not receive the login credentials immediately after the submission of the IFSCA application. Despite multiple follow-ups with the relevant NDML team, **the credentials were only shared with us on 24 March 2025.**

For your reference, please find attached the email received from the SEZ team sharing the login credentials.

As a result, the deficiency raised via Request ID 112500000782, dated 07 February 2025, was not visible to us until 24 March 2025.

As soon as we were able to view the deficiencies, we immediately rectified the deficiency and submitted the required information through the portal on 25 March 2025.

While we understand the importance of adhering to the timelines as stipulated by the Authority and remain committed to complying with the same, we sincerely apologise to the Authority for not being able to meet the timelines in this instance with respect to correction of deficiency.

We pray for your kind consideration in condoning this delay and issuing the Letter of Approval. We submit that the circumstances that led to the delay are genuine and beyond our control.

We trust that you will give this prayer your favourable consideration. We are committed to ensuring compliance with timelines of all applicable regulations in the future.

Should you require any supporting documents or further clarification, please do let us know."

Decision of the 53rd UAC: The UAC noted the submissions made by the applicant and after deliberations, condoned the delay in rectifying the deficiencies in the SEZ Online Portal within the stipulated time.
